Foreword

This publication is one of a monthly series containing data on medical assistance payments made under Title XIX of the Social Security Act (Medicaid). Information is compiled and reported by each State and/or jurisdictional agency administering an approved Title XIX program on Federal Report Form SRS-NCSS-120: Monthly Statistical Report on Medical Care. Currently there are 54 such programs in 49 States, the District of Columbia, Guam, Puerto Rico and the Virgin Islands. Arizona has not initiated a Title XIX program and Massachusetts has a separate State agency for blind recipients.

Prior to January 1974, similar data were collected for the midmonth of each quarter and midmonth quarterly reports have been published in this series since May 1967.

Reports for the months of March, June and September will include quarterly summary data and in addition, reports for December will include annual summary data.

Information presented include medical payments by form of payment, payments to medical vendors by type of service, number of recipients in whose behalf medical vendor payments were made, and data related to screening services under the Early and Periodic Screening, Diagnosis and Treatment Program.

This report was prepared by Annie J. Mayfield under the direction of Henrietta Duvall, National Center for Social Statistics. Statistical assistance was provided by Robert Terrell.

Introduction

Medicaid (Title XIX of the Social Security Act) is an assistance program designed to provide medical assistance to specified groups of needy individuals. Such persons are classified into two main groups according to their maintenance assistance status, (1) those who are authorized to receive money payments for their basic necessities under public assistance programs such as Supplemental Security Income and Aid to Families with Dependent Children, and (2) those who are not receiving maintenance assistance payments even though they may, in fact, be eligible. There are extensions of the maintenance assistance status categories but uniform procedures do not exist for reporting such data. There are four basic eligibility requirements for medical assistance: (1) age 65 and over; (2) blindness; (3) permanent and total disability; and (4) membership in families with dependent children. In addition, some States have exercised the option of including other needy persons who do not fall into any of the above categories. Such recipients are classified as 'Other title XIX' recipients in the accompanying tables. Also, 'essential persons' (usually spouses) may also be eligible for medical care. For money payment recipients, these persons are usually classified according to the same eligibility factors as the recipient spouse.

Generally, payments are made out of Medicaid funds to vendors (providers) of medical services, directly or through a fiscal agent as the direct results of claims filed by the provider after services are rendered. Data presented in this publication are generated as an adjunct to the Medicaid claims processing and payment operation. Thus, information is based on bills paid and not services rendered during the month. Consequently, the data provided through this process are not professed to represent a true picture of the incidence of illness among Medicaid eligibles and are subject to fluctuations unrelated to the provision of medical care. Monthly data are collected and presented to meet pressing current demands for minimum information on medical care financed under title XIX. However, States are required to provide more significant and detailed annual data on the numbers of persons receiving medical services, the number of units of such services and the corresponding amounts of payments.

Except for payments, data related to screening services are not necessarily generated through the claims payment process. Numbers of individuals screened are usually based on services actually rendered during the report month. As a result, payments reported for screening services may be unrelated to persons receiving such services.

HIGHLIGHTS

Medical Assistance (Medicaid) Financed Under Title XIX of the Social Security Act - January 1975

A total of 1.09 billion dollars was paid out of Title XIX funds in January 1975. An estimated 8.5 1/ million persons had medical vendor payments totalling 1.06 billion dollars made in their behalf. An additional \$2.9 million in vendor payments were made for screening services under the Early and Periodic Screening, Diagnosis and Treatment Program (EPSDT). There were concurrently 316,490 persons enrolled in Health Maintenance Organizations whose premiums were paid out of Title XIX funds.

Persons Served

More than half (55.5 percent) of the recipients for whom vendor payments were made were members of families with dependent children. AFDC children under 21 and other Title XIX recipients under 21 represented about 38 percent of recipients. About twenty-four percent of the recipients were eligible on the basis of age 65 and over. Seventy-six percent of the medicaid recipients were also recipients of maintenance assistance in the form of money payments. Among members of AFDC families, ninety percent of the recipients were also receiving money payments.

Amounts of Payments by Groups of Persons Served

Thirty-seven percent of payments to medical vendors were for persons whose eligibility was based on age 65 and over. Thirty-two percent were on behalf of members of AFDC families. The proportion of payments (23.4 percent) on behalf of permanently and totally disabled recipients was greater than the proportion of medical payments for either adults or children in families. Among members of families with dependent children under 21, eighty-four percent of payments for medical care were made on behalf of persons also receiving money payments, however, for the aged 65 and over, seventy-two percent of medical vendor payments were on behalf of persons who were not receiving maintenance assistance. Medical vendor payments for non-money payment aged recipients accounted for more than one-fourth (26.4 percent) of the total vendor payments. It should be noted that a large amount of these payments is probably made to medical institutional facilities which provide the basic necessities (food, shelter, etc.) and thus the recipients are not authorized for money payments for such needs.

Payments by Type of Services

About seventy-two percent of the medical vendor payments were made for inpatient services, i.e., hospitals (30.9%), skilled nursing facilities (23.3%), and intermediate care facilities (17.3%). Among other

services, physicians' services and prescribed drugs represented 9.1 and 6.8 percent of total payments, respectively.

Screening Services

Fifty-one States reported 147,011 children screened under the Early and Periodic Screening, Diagnosis and Treatment Program. Fifty-three percent of the children screened were six years of age and older. Forty-eight percent of children screened had referable conditions uncovered and eighty percent of those with conditions uncovered were referred for diagnosis and/or treatment.

Annotations

1. The following definitions apply to symbols appearing in the detailed tables.
 - indicates no data reported.
 - *** indicates that the percent was not computed because the base was too small.
 - Z indicates that the percent was less than 0.05.
2. Arizona has no **Title** XIX program and is excluded from the tabulations.
3. Colorado and Wyoming did not report recipients and payments by maintenance assistance status and basis of eligibility of recipients and are excluded from all applicable tables.
4. In addition to Colorado and Wyoming; Massachusetts, Nevada, Pennsylvania, and Utah are excluded from Tables 10-13 because children and adults in AFDC families were not reported separately. Connecticut, Illinois, Kansas, Minnesota, and West Virginia were able to report AFDC recipients separately but were unable to differentiate medical vendor payments between adults and children in AFDC families. These States are excluded from the total percentage computation in Table 11.
5. Premium payments into the SSA system for aged recipients in Georgia, Maine, Vermont, and West Virginia include payments for the disabled. For New York, data related to payments into SSA system for the aged or disabled were not reported.
6. Data are incomplete for Montana. Recipients and payments were not distributed by maintenance assistance status.
7. Data were estimated for New York and North Carolina and partially estimated for California and Michigan.
8. For Utah, all adult recipients i.e., aged 65 and over, blind and disabled are reported under money payment not authorized even though some may be SSI recipients.
9. In California, there were 92,208 persons in AFDC families for whom it was unknown whether they were adults or children. These recipients and the \$510,975 in vendor payments were distributed in the same proportion as the known amounts.

10. Vermont excluded \$4,652 for family planning services from the data reported in Tables 2-4, and 6-14.
11. In North Dakota, premium or per capita payments into/to SSA system and health insuring agency include data for the month of December 1974.
12. Minnesota included HMO recipients and premium amounts in the data in Tables 2-14.
13. North Carolina reported other Title XIX recipients under age 21 as AFDC children.
14. For Pennsylvania, other Title XIX recipients are not differentiated by age.
15. For Virginia, vendor payments do not include \$150,167 for transportation and \$2,056,824 for cost settlement and retroactive adjustments in Tables 3-4, 6-9, 11 and 13-14.
16. There was no payment of HMO premiums in January for Massachusetts.

Annotations specific for Table 5 (Type of Service)

17. For Connecticut, expenditures for other practitioners', clinic, laboratory and radiological, home health and family planning services are included in other care.
18. Expenditures for Kentucky include reimbursable cost adjustments of \$49,288 to hospitals, \$42,632 for nursing homes and \$103,239 for intermediate care facility for January and \$135,017 to mental hospitals for December 1974. The total vendor payments for Michigan exclude an accounting cost adjustment of -\$16,836. For New Mexico, vendor payments include \$21,896 in retroactive adjustments to general hospitals. In Rhode Island, payments include \$154,852 in retroactive adjustments to general hospital, \$23,458 for nursing homes, and \$17,858 for intermediate care facility. For Alabama, payments to general hospitals include \$7,584 for manual adjustments to hospital payments.
19. For North Carolina, physicians' services include optometrists.
20. In South Carolina, expenditures for skilled nursing facility services include \$25,355 for mental institutions.
21. In Virginia, family planning expenditures are included in other types of services.

Annotations specific for Screening Tables 15-20

22. Missouri did not report data on screening services for January 1975.
23. California reported 73,707 individuals receiving comprehensive physical examinations in addition to the screening data.
24. Data for Colorado exclude \$82,176 payments to Colorado Dental Society.
25. Data for Delaware include \$14,050 in adjustment for dental claims incurred prior to January 1975.
26. For the District of Columbia, data include reports from 78 National Capitol Housing Day Care Centers occurring from September through December 1974.
27. For Georgia, EPSDT screening data related to specified conditions are excluded from the tabulations.
28. Screening payments for Idaho, Illinois, Georgia, New York, Pennsylvania, and Texas are not reported separately for ages under 6 and 6-20.
29. In Indiana, the 1,590 persons screened during the month with referable conditions uncovered were not referred for treatment because they were either currently receiving treatment for the condition or parent did not desire treatment.
30. Data for the District of Columbia, Massachusetts, North Dakota, Ohio, Rhode Island, and Vermont are largely estimated, provisional and/or incomplete.
31. For Rhode Island, data include 98 newborns for whom payments are reflected in physicians' or hospitals services. There were an additional 57 persons screened for whom detail information was not available.
32. Payments for screening services were not reported by the District of Columbia, Indiana, Kansas, Maryland, Massachusetts, Michigan, Puerto Rico and the Virgin Islands.
